An article in the San Francisco Chronicle (Electric bicycle ban on trails staying put--Per report, e-bikes could impact safety and environment) was brought to my attention today. I have copied some pertinent information regarding this decision, which I think is relevant to the Waterdog Open Space here in Belmont. Yes—some regions have opened up trails to e-bikes, but I think there is a big difference between recreational areas or parks, which have the primary purpose of recreation, and nature preserves with a primary purpose of preserving the natural environment. Below are quotes taken from the article. I added italics to emphasize the last statement.

"Midpeninsula Regional Open Space District voted to uphold its ban on e-bikes on the majority of its trails."

"Observing that e-bike use has exploded in the region, the district undertook a thorough two-year policy review that looked at the potential impacts of allowing e-bikes on its nature preserves. In an exhaustive report, the authors assessed noise impacts to nearby bat populations, potentially excessive uphill speeds, fire risk, soil impacts, and the potential for conflicts among e-bikers and other visitors."

"The four directors who voted to keep the ban largely in place noted that Midpen's mission is to balance healthy natural ecosystems with agricultural and recreational uses and view its preserves as distinct from parklands in that way."

"What I want to emphasize is our job is to properly care for nature preserves, and it's a very different approach required by agencies that are managing parks," said Midpen Director Curt Riffle. "I've concluded that I just cannot support allowing motorized or motor-assisted bicycles into our preserves." Director Karen Holman echoed that rationale, describing possible unknown negative impacts to wildlife wrought by e-bike riders who might venture down Midpen trails farther and faster than mountain bikers."

"Overall, directors expressed trepidation about a lack of scientific research on e-bike impacts in natural areas. 'One consideration ... is that based on our past history, once a use is allowed in an area, it becomes more difficult to restrict that use if we find that negative impacts are indeed occurring,' said Midpen General Manager Ana María Ruiz."

This last point is critical to consider in the implementation of a pilot policy, as suggested on page xvi of the draft Open Space Master Plan. Also, it is apparent to me that opening up trails to e-bikes is not required to adhere to ADA regulations, given that the Midpeninsula Regional Open Space District voted to uphold its ban.

Thank you for your careful consideration of this issue as you move forward.

7/3/2022 Hi Brigitte, Kristin Mercer I want to call your attention to three significant errors on the PROS Drafts released June 28, 2022. These are not differences of opinion, but factual errors. I respectfully request these errors be corrected prior to submission of the drafts to City Council, and that these corrections be conveyed to the Commission in the July 6 discussion on the topic. I would greatly appreciate an e-mail acknowledgement of receipt of this notice, and confirmation that the errors will be corrected. Thank you, Kristin Mercer Unauthorized Trails incorrectly identified as authorized (WRA Draft Final Open Space, pg. 6 and 20) On the WRA trail maps, six illegal trails are mis-labeled as authorized (solid black line). As you can see on the most recent City trail map below, these trails are NOT authorized and were not approved by the City for good reasons: Ralston School – poses a security risk to students, was steep and badly eroded. This trail was closed by City actions in 2021. Berry shortcut to Brooks - dangerously steep, redundant because it connects two trails that intersect just a few yards to the east Chaparral to Brooks at Highlands Court - redundant because it connects two trails that intersect at the Somerset entrance, dangerously steep and eroded, bisecting chaparral Elevator down to Chaparral - dangerously steep and eroded 2 ft ditch, causing widening yearly, bisecting chaparral habitat. From Ohlone to Ohlone – redundant, dangerous slope and cross slope with trail width less than 1 foot, undermined roots and killed two previously healthy oaks, bisecting sensitive oak and fern forest and introducing invasive species. Hastings Drive to Upper Creek - redundant, dangerously steep, highly eroded and widened beyond 10 feet. Many of these trails were identified by residents in 2020 when the City was asked, and promised, to close them. Ralston trail was closed at that time. Ohlone appeared in 2020-21. Hastings has been closed or not-used for many years. Taken together these mistakenly mapped trails add to about a mile. On top of these we have the 1.5 miles of illegal trails in the Brooks Preserve (not shown here). All totaled, illegal trails account for an added ~20% more trail miles than the City acknowledges. None of these trails have trail signage because the 2020 Trail Signage Committee acknowledged that these are NOT official trails. Illegal trails are a significant management issue that is totally omitted from the WRA assessment and recommendations, and should be documented as an area of focus. There is no justification for sanctioning these dangerous, redundant, unsustainable, unplanned and illegally created trails. Please revise the WRA maps to remove these trails. And again, please take action to close these illegal trails. E-bike policy -MidPen Open Space does not permit e-bikes (WRA Draft Final Open Space, pg.43) The WRA Draft Open Space Management Plan implies, on pg 43, that MidPen is poised to permit e-bikes on trails. In fact, at their June 29 meeting the MidPen board voted to ban e-bikes from narrow natural surface trails. This decision was based on an exhaustive study of impacts and policies of other open space stewardship agencies. It is thus reflective of the emerging "best practices" in light of the rapidly evolving e-technologies and growing use impacts from bike activity. The WRA draft needs to convey this recent

As reported in WRA's final draft Open Space Management Plan (OSMP) the majority of visitors to open spaces seek nature:

"exercising, communing with nature and experiencing peace and quiet" was cited in the 2021 Belmont survey as the leading purpose of visiting the Open Space.

"walking, hiking and running while a much smaller proportion reported biking" was also the response to a survey of visitors to San Mateo County parks.

Yet in Belmont's Waterdog, these purposes have been totally reversed with biking now the predominant activity, preventing residents and others from walking, hiking and running in peace and quiet, and communing with nature. The PROS guiding principles call for equity and inclusiveness, but currently the majority of residents are denied equitable access and inclusion; they don't feel welcome and safe and don't feel that their health and well being are advanced.

Bikers have argued that pedestrians are equally welcome to use the narrow trails and insist they are inclusive, but this argument is disingenuous because bikes on trails meant for hiking are forcing foot traffic out of Waterdog. We have an exclusionary, regional bike-dominated destination. By creating dangers to pedestrians with competitive speeding up to 30 mph on the curves of narrow trails; seeking ever steeper slopes and jumps for excitement, and building berms around narrow curves for enhanced speed they have scared away neighbors with small children, driven away avid senior hikers and created an environment of fear of walking in Waterdog. And this exodus is being encouraged by a San Mateo bike leader's audacious public comments telling Belmont residents to go take a hike elsewhere other than Waterdog (click video link).

Let's be honest; no amount of "trail calming features" (bells, greetings, flat landings, slower speeds, reminder signs) will be enforceable and none of them will improve biker/hiker compatibility. Hikers walking at 1-5 mph seeking peace and quiet cannot compete with speeding 2- wheel machinery traveling up to 30 mph, whizzing past within inches on a 3-foot wide trail. This is neither safe nor conducive to either user group attempting to enjoy Waterdog, and is an accident waiting to happen.

The compromise solution is to make the 5 following narrow trails - Lake Loop, Berry, Chaparral, Canyon Creek and Ohlone - off limits to bikes while all other authorized trails can be used by bikers (8 trails). All 5 of these narrow trails designated by the 1999 City Council for hiking only, are very steep or winding, have blind curves and few safe passing zones. Many slippery areas need staircases to make them safe for pedestrians, and stairs are not compatible with bikes. ALL trails can be open to all visitors on foot – without allowing access by machinery. Designate these 5 trails off limits to bikes and build safety staircases where necessary to enable the majority of park visitors who are now displaced from our trails.

As you finalize your recommendations to City Council for approval, please keep in mind your guiding principles for the majority of users. Waterdog needs separate trails for separate users because peace and quiet, communing with nature and most importantly, pedestrian safety are just not compatible with speeding bikes.

Don't let Belmont's Waterdog continue to be known as one of the only 2 local open spaces that allow bikes on every single trail; forcing hikers to go elsewhere, because such a City policy is truly neither equitable nor inclusive at all.

7/5/2022 The major harm that mountain biking does is that it greatly extends the human footprint (distance that one can travel) in wildlife habitat. E-bikes multiply that footprint even more. Neither should be allowed on any unpaved trail. Wildlife, if they are to survive, MUST receive top priority!

What were you thinking??? Mountain biking and trail-building destroy wildlife habitat! Mountain biking is environmentally, socially, and medically destructive! There is no good reason to allow bicycles on any unpaved trail!

Bicycles should not be allowed in any natural area. They are inanimate objects and have no rights. There is also no right to mountain bike. That was settled in federal court in 1996: https://mjvande.info/mtb10.htm . It's dishonest of mountain bikers to say that they don't have access to trails closed to bikes. They have EXACTLY the same access as everyone else — ON FOOT! Why isn't that good enough for mountain bikers? They are all capable of walking....

A favorite myth of mountain bikers is that mountain biking is no more harmful to wildlife, people, and the environment than hiking, and that science supports that view. Of course, it's not true. To settle the matter once and for all, I read all of the research they cited, and wrote a review of the research on mountain biking impacts (see https://mjvande.info/scb7.htm ). I found that of the seven studies they cited, (1) all were written by mountain bikers, and (2) in every case, the authors misinterpreted their own data, in order to come to the conclusion that they favored. They also studiously avoided mentioning another scientific study (Wisdom et al) which did not favor mountain biking, and came to the opposite conclusions.

Mountain bikers also love to build new trails - legally or illegally. Of course, trail-building destroys wildlife habitat - not just in the trail bed, but in a wide swath to both sides of the trail! E.g. grizzlies can hear a human from one mile away, and smell us from 5 miles away. Thus, a 10-mile trail represents 100 square miles of destroyed or degraded habitat, that animals are inhibited from using. Mountain biking, trail building, and trail maintenance all increase the number of people in the park, thereby preventing the animals' full use of their habitat. See https://mjvande.info/scb9.htm for details.

Mountain biking accelerates erosion, creates V-shaped ruts, kills small animals and plants on and next to the trail, drives wildlife and other trail users out of the area, and, worst of all, teaches kids that the rough treatment of nature is okay (it's NOT!). What's good about THAT?

The latest craze among mountain bikers is the creation of "pump tracks" (bike parks). They are alleged to teach bicycling skills, but what they actually teach are "skills" (skidding, jumping ("getting air"), racing, etc.) that are appropriate nowhere! If you believe that these "skills" won't be practiced throughout the rest of the park and in all other parks, I have a bridge I'd like to sell you! ...

The common thread among those who want more recreation in our parks is total ignorance about and disinterest in the wildlife whose homes these parks are. Yes, if humans are the only beings that matter, it is simply a conflict among humans (but even then, allowing bikes on trails harms the MAJORITY of park users -- hikers and equestrians -- who can no longer safely and peacefully enjoy their parks).

At the last minute, I'm offering a summary of my (scattered) thoughts regarding the Belmont PROS Plan. You both have invested a tremendous amount to time and energy shepherding this endeavor and I am so grateful to live in Belmont because of efforts such as yours.

I believe my primary input to the panel was to be slanted towards our OSP which is fine since I hike in San Juan Canyon, Waterdog and or Hidden Canyon on a weekly basis; twenty plus years ago you would find me on my bike. To that end, my opinions are both as a biker and hiker, as well as a mother to an avid cyclist.

Belmont enjoys the unique situation of having access to bike bridges spanning both 101 and 280 - I am not aware of another City on the Peninsula which has that feature. Add to that our wonderful open space for mountain biking, the presence of Belmont Bike shop, plus easy access to restaurants and shops along Ralston Avenue, and we have a city that should be a cyclist's destination. Perhaps the City could officially declare that we are bike-friendly in both access and safety.

Bike-friendly does not mean that mountain bikers can rule the trails. I think the our OSP should be viewed for mellow, after-work or -school rides and a place to learn safe skills. This can be communicated via social media on various biking websites with the emphasis that our OSP is not where you bomb down the trail, but where you share it with flora, fauna and those not on bikes. I believe this message may be being shared already.

I would ask that the City keep an open mind to reviewing the trail system to add an additional trail or two in an effort to better connect the OSP and, more importantly, to spread out the trail users. A thoughtfully placed and designed trail can ease over-use of an area, enhance enjoyment and potentially decrease any user conflict. For instance, there could be benefit to connecting Lake Road with Hidden Canyon via a trail towards Elevator.

I was very pleasantly surprised that the WRA assessments found that our OSP is in good shape, especially considering the amount of use. I have personally seen the results of various volunteers clearing non-native brush and decommissioning unauthorized trails/shortcuts. The land looks better. Addressing the erosion on trails will further enhance the robustness of the system. The water crossing have always been a concern since I realize the importance of keep feet and wheels out of water as much as possible. Unfortunately, these water crossings that do not have a good overpass are mostly on unauthorized trails in both Waterdog and San Juan Canyon.

To address the water crossing, the City of Belmont needs to decide whether to recognize the two Waterdog trails that are currently unauthorized, but appeared in a decades earlier City document, as well as the trails in San Juan. I realize this puts the City in a bit of a sticky wicket since I have no doubt some type of action will be instigated by a few anti-bike activists. However, the City needs to make the decision so we can move forward on management of our open space.

That is what I have felt all along in this PROS process, the City needs to make the decision on what trails will be authorized. Only then can we move forward to safe guarding our open space. I am guarded on designating trails for a certain user group; instead I wold rather see all trails be able to handle all users.

Thank you for allowing me to participate. I so wish we could have met in person as Zoom can be such a barrier to seeking common ground, but nevertheless I appreciate the opportunity to join the process.

The Open Space Element of the PROS plan has not received the transparent and public review that the Developed Parks section received. The PROS Park Specific process was discussed and revised over 2 years, whereas the Open Space draft was only released in June, and never fully reviewed. The Commission should have recommended only the Parks section and continued public discussion of Open Space policies at their July 6 meeting.

The PROS Open Space process officially started on March 5, 2022 with WRA initial recommendations, lacking the promised trail assessment. The report was vague and incomplete, and thus the committee deferred discussion. On 5/27 that WRA assessment was published – 2 days before the 5/31 PROS meeting, allowing no time for the committee to read or absorb the content. The OSMP final draft (136 pages) was not published until the day before this July 4th holiday weekend, and readers are now discovering serious oversights and missing key elements necessary for a basic framework for a Master Plan.

I could see that the P&R Commissioners were struggling to make an approval decision just a day after receiving the "final" drafts totaling approx 300 pages. They openly expressed concerns, but felt pressed to act in order to meet your July 12 City Council meeting deadline. Under pressure to make a decision the Commissioners reluctantly approved the entire plan and at the last minute resorted to narrating multiple amendments to the Open Space element on the fly before recommending this inaccurate and incomplete document to you. The Open Space process was crammed into a 6 week period while the Park Specific process had over 2 years; neither equitable nor transparent and the result is half baked. Serious issues in the Open Space that need to be addressed now are being swept under the rug in this OSMP.

I reexamined the current 1992 MP Open Space policy (Section VIII) to make some comparisons to this Open Space policy in the new OSMP. Ironically, the 1992 Open Space plan has more concrete policies and direction than the new plan. Two core issues that need to be addressed now are being kicked down the road as "future amendment projects".

Trail Use and Design Guidelines: The 1992 Open Space plan (pg 45) established clear policy guidelines with definitions of multi-use and single-use trails. The City has failed to enforce these policies for two decades, and as a result this issue is at the core of all current conflicts. Instead of addressing this issue head on, as promised to residents at the outset of the plan process, this draft dodges the issue, and leaves the city without any clear trail use policy.

The 1992 Master Plan designated 7 single-use trails for hikers only; why won't the P&R just designate 5 of these trails off limits to bikes so pedestrians can be safe? These 5 narrow trails (Lake Loop, Berry, Chaparral, Canyon Creek and Ohlone) are the most narrow, winding, lacking line of sight, steep, and deep in the valley which make them the most dangerous for hikers and bikers to share. Why are our P&R commissioners willing to believe bikers over hikers? Safety is a key objective of the plan, yet here it is totally ignored, as new Commissioner Simpson stated. Continuing to allow all trails to be multi-use is increasing serious safety issues and liabilities the City can least afford. With increasing bikers from all over the Bay area descending on Waterdog for competitive speeding/entertainment, biker/hiker accidents are going to increase, as indicated by last night's public comments and my previous video emailed to you. This very core issue is dividing our community; families, seniors and residents now avoid walking Waterdog, and instead drive elsewhere. In public statements, the bike-volunteer organizer even had the audacity to tell residents to go hike elsewhere! This policy needs to be addressed and established in this document now, not as a future amendment project.

Illegal Trails: This issue was not a concern in 1992, before the advent of mountain biking, but is a serious issue now. For decades bikers, in the name of volunteer trail maintenance, have built unauthorized, illegal trails beyond the official 13 trails listed on the City map. Illegal trails and shortcuts have added an estimated 20% more miles to the official approved trail system. In particular, in 2017, bikers illegally built their "Labor of Love" trail in the valley below Soho Circle, plus a trail bisecting the Brooks Preserve protected marsh habitat. Bikers repeatedly claim they are justified in riding every Waterdog trail because they volunteer to do trail maintenance. Volunteers should not be getting special benefits and immunity from vandalism laws as payback because of their efforts. Do we sanction graffiti vandalism because of the effort put into it by the artist?

This draft proposes to establish a policy of sanctioning illegally created trails without consideration of trail safety standards, environmental impact compliance, or public process, a completely irresponsible policy. Back in June of 2020, Brigitte stated that illegal trails like this one behind Soho Circle would be addressed in the new Master Plan. It has not, and it is a core issue that needs to be addressed now, not as a future project.

Frankly, these two issues have been concerns for decades and never properly addressed. With the opportunity to approve a new 15 year Open Space Management Plan, now is the time is to address these serious issues instead of kicking the cans further down the road.

I have had many very dangerous close encounters with cyclists on the very narrow steep trails in the Belmont Open Spaces. It is to the point where I have to walk on other trails where other cities have tight controls on cyclists. On this week's Council agenda, the Parks and Rec Commission and Department will present you with a finalized Belmont Parks and Recreation Open Space Master Plan. This plan represents the culmination of 18 months of community outreach, an extensive public survey, focus groups, an advisory panel, two separate and independent consultants, and month-after-month of discussion and public commentary. The process has been exhaustive, transparent, and inclusive. Please vote in favor of the plan so we can move forward with a clear vision for our open space.

I want to take the time to commend the Parks and Rec Commission and Director Shearer's Department for their leadership and effort in getting this plan together. They conducted one of the most successful public surveys ever performed in Belmont and truly took the time to understand how the public uses our open space and what was desired in the future. They also brought in recognized experts in ecology, open space management, and habitat preservation in order to analyze the state of our open space and tell us how we have been doing. The PROS Master Plan incorporates both the science and the public will into a plan that we can all be proud of!

Now there are always haters, and as the saying goes, "the haters are gonna hate." You will hear from them this week: Deniz Bolbol (yes, the same Deniz who almost destroyed the beloved Belmont Cross Country Course access last year), her husband Pat Cuviello (failed City Council candidate), Kristen Mercer, (another failed City Council candidate) and Jennifer "Jen-Jen". We have heard from these four in every meeting for 2 years now. First we heard about how the open space was in shambles, the animals had been run off, the bikes had completely eroded the trails, and Waterdog was an ecological disaster. In truth, our expert consultants found that Waterdog is in pretty darn good shape - the flora and fauna are quite healthy, invasive species are lower than comparable open spaces, rogue trails and cut-throughs are less prevalent than comparative open spaces (for instance, in Marin), and the singletrack trails (made by cyclists) actually have less erosion than the old dirt roads (John Brooks, Rambler, etc) we inherited from the past. Next we heard that Belmont residents wanted a nature preserve. In truth, our Belmont PROS survey found that the majority of Belmont residents used the open space for recreation, and the majority actually desired more trails and more recreational opportunities. I would also remind the council that this survey reported results separately for both Belmont residents and non-residents. It turned out that both Belmont residents and non-residents agreed - the majority wanted to preserve and expand recreational open space access. Next the haters told us that Waterdog is unsafe for hikers - a claim used to justify restricting cyclist trail access despite the fact neither Parks and Rec, nor Belmont Police, have received significant reports of collision with injury. Out of desperation, at one point Deniz took to standing around a blind corner, while her husband Pat filmed, in hopes of entrapping a cyclist and documenting a collision. This bizarre behavior was reported to the Council earlier. No collision occurred. Although I can understand that hikers may want to have an experience without dogs or cyclists around, hikers have a plethora of nearby hiking-only trails to choose from: Crystal

Springs Cross Country Course (17 feet from the Upper Lake Trail trailhead, 299 acres, 3 miles of trails), Big Canyon Park (16

acres, 1.7 miles of trails), Pulgas Ridge Preserve (366 acres, 6 miles of trails), Edgewood Preserve (467 acres, 10 miles of trails), Eaton Park (158 acres, 2 miles of trails), Mills Canyon Park (1,500 acres, 1.4 miles of trails), Phleger Estate (1,000 acres,

4.6 miles of trails), Huddart Park (973 acres, 28 miles of trails), and Foothills Park (1,400 acres, 15 miles of trails). In contrast, there are no cycling-only trails to serve the recreational needs of cyclists. For every mile of mixed use trails like Waterdog,

there are over 5 miles of hiking-only trails within a 15 minute drive of Belmont, and no cycling-only trails. How could further restricting cycling access be fair? Finally, the haters, sensing their own defeat, will tell you this plan was sprung upon them.

and the public has not had the proper time to read and digest it. In truth, the Commission and Department has done a fabulous job socializing this plan - we've had monthly Commission meetings, advisory board meetings, scope planning meetings, surveys, web

campaigns, meet-and-greets in the park. The draft plan has been available for months and the finalized plan, incorporating even more input, contains no surprises. These haters have sought to sabotage the PROS process since day one. The haters, who seem to

only know how to destroy a community, have had their say. Now, after two years, it is time to move forward.

Belmont residents have a beautiful open space to

hike, cycle, exercise the dog, enjoy the flowers and trees, get some fresh air, meet friends, and build community. It is a place of joy, peace, and fun.

As a Belmont resident of 30+ years, I am quite familiar with the trails at Waterdog Lake. For a while, I hiked them regularly but the continued and increased use of speeding mountain bikers on the narrow trails have left me fearing for my safety. Having to jump out of the way at a moment's notice takes the enjoyment out of a hike. In addition, I'm upset about the disastrous consequences to the trails, the surrounding sensitive habitat and the wildlife caused by erosion of the existing trails

Speeding mountain bikes, bike jumps, night biking and illegal trail construction are not in line with the goals stated in the Plan for Belmont's Open Spaces, such as making all users welcome and safe, Environmental Resource Protection, Balanced Recreation Uses and Trail Management and the Trail Standards and Guidelines.

A quick search for prime mountain biking locations in San Mateo County reveals that Waterdog is near the top of the list. It is described as a singletrack mountain bike trail, and while the person in the introduction points out that it is a multi-use trail system and requests fellow riders to be courteous, the reviewers talk about the technical difficulty of the trails.

These difficulties, such as exposed roots, were not part of the original trails which were meant for hikers, and now they pose a long-term danger to the trees themselves and also to the safety of hikers.

Before you adopt the Open Space Master Plan, you must include the following:

Keep bikes off the narrow, steep and sloping dirt trails to prevent further erosion and to make them safe for hikers.

Close ALL unsanctioned trails. Do no sanction this form of vandalism. It will only encourage additional illegal trails. Instead, all unsanctioned trails should be restored to their original state, if that is even possible considering the damage that has been done from both the construction and the use.

E-bikes should only be allowed on Lake Road.

Part of what makes Belmont such a wonderful place to live is the proximity to a place like Waterdog Preserve. Yes, there are plenty of other preserves in the area, but why should Belmont residents be forced to drive out of town, so that mountain bikers can use the space and continually degrade it?

Please make sure that Waterdog Preserve will have trails that are for hikers only so everyone can enjoy this precious resource.

I am si yum and have been residing at carlmont drive since 1997. I used to love this city because of the beautiful open space and peaceful walking trails. In the recent years, increasing numbers of mountain bikes basically took over all trails.

Finally, I became the victim of this situation. Nov. 11, 2020, while my husband and I were walking on the water dog trail, I saw 3 bikes side by side running toward us. To avoid being run over, I quickly left the trail by crossing over the ditch (water drain) and up onto the slope. When I tried to return from the slope and over the ditch to the trail, I fell because of the slippery sands on the trail making me lose my balance.

My right foot and ankle were injured, and I could not walk. I called the city and the park service and left a message and asked for someone to open the trail gate/bar so that my husband could pull his car in and take me home. No response at all.

I called my daughter but she and her husband were in Oakland. I had to wait couple hours for them to drive over, find me on the trail and carry me back home. I spent almost 3 months on a wheel chair and slept on a sofa and took no bath. (Bed and bath are on second floor). X-ray, taken by dr. Rachel Wood in March 2021, showed my lower leg bone had a crack. Thought I feel my feet was somewhat recovered but swelling and paint are still existing. My right leg has no strength to support body balance. I am afraid of falling. I have physical therapy for a year. Lately, I received a steroids injection and will receive another dose soon. Dr. Wood says my foot most likely will stay in pain for the rest of my life.

Lately, I get back to the hiking trails nervously. I kept thinking of how to protect myself, carrying a stick or/and a pepper spray... Or you tell me what kind of effective defensive tool I should carry with me to prevent another injury? Hikers on foot who want to enjoy our trails cannot defend themselves from a bike especially when they travel so fast.

As we all know, on Ralston st, there are pedestrian way, bike lane and auto lanes. Pedestrians have the priority over all others. All others have to yield. Why not on the trails? Now, my husband loudly yells to warn me if he feels a bike approaching.

Here, I demand the city to designate hiker trails and biker trails. If it is difficult to do, designate time, for instance, Monday and Wednesday for bikes and other days for hikers. We are Belmont homeowners and residents near the Waterdog Open Space, as well as frequent users of the Open Space. We support keeping Waterdog Open Space an accessible and sustainable place for outdoor recreation, but in a manner that is inclusive, suitable, and safe for ALL users.

1. We believe the proposed Open Space Management Plan does not adequately evaluate, plan for, or address the major issues with multi-use in the Open Space and how Belmont will manage it. We found the plan to be lacking in this area and ask for revisions to properly address some of the points below.

2. We also believe there has not been sufficient time for Belmont residents to review the details of the extensive doc before it is finalized. We ask that the city's vote on this plan be postponed until there has been enough time for review and feedback — very few have had the opportunity to digest the recently published doc with the actual plan details, after 18+ months of process and input from the community.

## Our personal experiences:

The trails in the Open Space are mostly narrow and steep, single-track trails which are already difficult to share by nature -- combining with the continual increase in bikers and general high trail usage density has made it more and more difficult to fully enjoy the trails, especially as a frequent hiker/dog walker. Personally, we avoid hiking in the Open Space at many times (such as weekends and weekday evenings) since it is often not an enjoyable experience as a hiker given the bike traffic -- anecdotally this is a common theme and we expect many other hikers to have similar experiences. Despite generally pleasant and courteous interactions with bikers, we still end up having to actively avoid bikes or step off of narrow trails frequently, especially for groups of bikers. Unfortunately when conditions aren't suitable for multi-use, it's usually hikers who end up primarily excluded from safely and fully enjoying this outdoor resource.

Our concerns with the current Open Space plan include the following:

It does not include adequate evaluation on the safety, suitability, and practicality of the current shared-use trail structure throughout Waterdog.

This should have been conducted on a per trail basis and evaluated against well-established best practices and standards on shared use.

It does not address how Belmont plans to manage safe, multi-use trails, especially at its very high usage volumes.

There is minimal detail provided on how to manage multi-use beyond reducing speed and best effort user education; the few points that are included are fairly generic.

There is also no real mention or consideration for usage volume -- the plan suggests to "Measure recreation use in open spaces" but this does not seem like it was actually done, though it should be a critical input into the final plan and policies.

It does not actually provide useful policy decisions or guidance on important points like single-use trails or e-bikes.

Even the 1992 Open Space Master Plan provided more specific details in terms of trail guidelines (and it specifically designated multi-use as gravel 10-12' wide trails). It has a section on "Trail Design Features Specific to Mountain Bike Trails", pointing to Chapter 6 in the CA State Parks and Rec Trail Handbook. This chapter is specifically about designing "designated mountain bike trails", "specifically for cyclists" (quoted directly from the handbook), which should not be a primary consideration in designing our Open Space and shared use trails.

Belmont's Open Space should not be focused on designing mountain bike trails, but rather continue to emphasize preserving open space as originally intended, while allowing and supporting multi-use and mountain biking where appropriate. The Open Space plan puts more detail into mountain bike trail design than actual guidelines on how multi-use should be effectively managed throughout to provide a safe and inclusive shared used open space.

Overall, we found the proposed Open Space Management Plan to be very hand-wavy with inadequate detail on trail management and specific policy recommendations. It does not sufficiently address the concerns around multi-use voiced by many Belmont residents, and over-indexes on mountain bike trail design while not preserving the spirit of the original Open Space Master Plan and the goals of Belmont's Open Space.

If the PROS plan is intended to guide our parks and open space for the next 15 years, we expect that it thoroughly addresses the major concerns and contains actual policies and quidance. As is, it feels like the city is rushing to adopt a long-term plan that is incomplete and missing critical evaluation/studies and details.

I live with my wife and three children (ages 10, 13, and 15) in the Cipriani neighborhood. When we moved to the city in 2005, we chose this city above others because of its natural beauty, abundant trees, great schools, and its multi-use open space trail system. Every day we are grateful to live in a city that had the vision to preserve the open space for our hikers, bikers, trail runners, and dog walkers to enjoy. Regularly we hike with our dog, and at other times we ride our mountain bikes throughout this trail system. We are a happier and healthier family, by virtue of this amazing resource.

Over the past 18 months, I have been involved with the PROS plan effort as a community member, attending and speaking in favor of multi-use trails at several public meetings in this very transparent process. Many community members got involved when we learned that there was a small vocal minority looking to shut down trail use to mountain bikes, and potentially to other user groups as well. When the city conducted a high-quality survey, we learned that the vast majority of community members strongly wish to preserve our multi-use trail system access as is. We want to keep our trails open for everyone to enjoy, and this is reflected in the opening principles of the PROS plan – to promote inclusiveness and equity.

I have been impressed with the Parks and Rec Commission, Parks and Rec Department, City Council, and our consultants Gates and Associates and WRA. Our city representatives have been very thorough and professional, even when verbally attacked by certain community members.

The Parks and Rec Commission has now voted to support the current PROS plan. I have included a few of the points I found most interesting below:

- 1.) Both Waterdog and San Juan open space are in good environmental health (flora and fauna).
- 2.) Mountain bikes are not causing erosion or significant damage to the trails
- 3.) The open space trail system should be maintained as a multi-use trail system, based on community feedback and scientific evaluation by WRA.
- 4.) WRA did identify some issues with creek crossings, erosion, trail congestion, safety and suggested that these can be mitigated by measures such as building appropriate bridges, fixing the trail lines of the old erosion-prone fire roads, providing calming features and pull outs for passing hikers and bikers.
- 5.) There may be opportunities to build additional trails to better serve our user groups and reduce potential congestion on the trails.

I fully support the PROS plan that comes to Belmont City Council for review tomorrow, but wanted to address a couple of specific items in this letter:

First, there is a question of whether or not to consider one or more trails as 'hiker only' or 'biker only.' Focusing on our PROS principles of inclusivity and equity, in a park that has long cherished its multi-use traditions, keeping the trails open to everyone seems to be the natural path forward. Trying to segregate certain user groups from certain trails is likely to lead to more user conflict in my opinion, not less. The current, simple, multi-use system is inclusive, equitable, and it is clearly working for the community. Lets not change this!

Second, there is discussion about a pilot study for evaluating e-bikes on the trails. I support this study, because we don't know enough yet about how e-bikes impact the park. I think it is likely that the study will show that e-bikes do no additional harm to the trails. At that point it really just becomes more of an aesthetic choice... Do we want these in the park? We'll find out after some more evaluation and thought.....

Lastly, certain members of the community complain that this process of developing the PROS plan was rushed, and non-transparent. They will complain bitterly that this was pushed through with insufficient time to review documents. But as you also know, the city elected to extend the process from a lengthy 12 months to an even lengthier 18 months specifically to accommodate more scientific study and to allow for a truly amazing amount of community outreach. It is clear to me, and many others, that the city has done a remarkable job on this extensive, transparent and scientific PROS plan. Delaying a vote in order to continue the debate will not provide additional gains in terms of further knowledge, but it will detract from much needed efforts elsewhere in the city.

Thank you for your time in reading my lengthy letter! But more than that, thank you for your dedication to our city and our community.

I wanted to offer some comments about item 9A on the agenda for tomorrow's meeting (Review and Adoption of the Parks, Recreation, and Open Space Master Plan). I'm sure you're receiving a lot of feedback so I wanted to briefly (for me) address some main points:

1. The staff recommendation to keep all trails multi-use, preserving the status quo, is the most reasonable path forward.

The draft plan references looking into designating one unmapped trail cycling-only and one pedestrian-only, but otherwise does not recommend making any existing trails single-use. I'm well aware that a handful of people from Belmont Heights are demanding hiker-only trails. It might seem tempting to designate a few single-use trails as a compromise to a perceived conflict. However, designating single-use trails would represent a wholesale and radical change to the trail policies that have worked successfully for 30+ years. All of the trails in Waterdog have always been multi-use, and there's no compelling reason to segregate them now:

The unbiased scientific study by the city's consultant (WRA) concluded that the existing recreational use (i.e. full multi-use) is not having a significant impact on the environment. So from an ecological perspective, there is no reason whatsoever to designate any trails single-use;

Designating any single-use trails (whether pedestrian-only or cycling-only) fosters division and resentment in the trail user community;

Belmont doesn't have a dedicated park ranger, so there's no practical way for the City enforce the rule;

Unfortunately, we have a few angry individuals in our community who have been known to physically accost and confront cyclists on the trails. If a cyclist intentionally or unintentionally rides onto the wrong trail, a self-appointed vigilante enforcer may confront or assault him or her;

Commissioner Michaels made an excellent point at the last P&R Committee meeting, to the effect of "we should allow as many people as possible to enjoy all of our trails," which is consistent with the PROS principles of providing equitable access to resources and activities across the entire city and promoting inclusion to people of all backgrounds; The federal Bureau of of Land Management has a publication, Guidelines for a Quality Trail Experience, that makes insightful points about shared multi-use trails: (1) "Sharing helps build a trail community. Visitors are encouraged to cooperate in order to preserve and protect a common resource, and encountering other types of users on a trail helps to establish mutual respect and inspire courtesy." (2) "Shared-use trails take better advantage of available space and trail mileage. Quite simply, they provide more trail for everyone to enjoy."

There are no documented instances of a bicycle vs. pedestrian collision in over 30 years of multi-use. To the extent some individuals have safety concerns, those can be remedied by respite bulb-outs and trail calming features, which the consultant has already included in the plan.

2. The draft plan's e-bike policy - a pilot program - is sensible and should be implemented.

The draft plan recommends a pilot policy allowing Class I (pedal-assisted) e-bikes on Waterdog's trails for at least one year to allow for further assessment. This is a rational and sensible way to deal with the relatively new phenomenon of e-bikes. The City is a small land manager and doesn't need to reinvent the wheel, The Midpeninsula Regional Open Space District (MROSD), which manages 65,000 acres of open space, is currently conducting e-bike studies and experimenting with e-bike policies. The City can keep an eye on what MROSD is doing while simultaneously gathering its own data about how e-bike use is (or is not) affecting the Waterdog open space trails. After gathering enough data, the City can then get public input and make informed decisions, rather than kowtowing to people who are clamoring for an immediate ban without any justification.

I don't think e-bikes should either be allowed in perpetuity or banned in perpetuity at this point - we don't have enough data to make an informed decision, so why not let the pilot program play out? Again, it may be tempting to implement a pat, "compromise" solution by limiting e-bikes to certain trails, but that will only result in limited and inconclusive data upon which to base future decisions for more permanent policies.

3. The PROS process was not rushed and there has been robust public input and consideration; there is no need to delay the decision.

I think the city has done an outstanding job of making this 18-month process transparent and inclusive. The City did online outreach, sent physical mailers, and created a dedicated PROS plan website with regular updates. There has been ample opportunity for public input through surveys, many public meetings, and the convening of a PROS committee. A group of activists paid for their own study with their own biologist, which was read and considered by the consultant. In addition to traditional public comment, members of the public were even given an opportunity for a back-and-forth dialogue with City staff and WRA at the open house event. The PROS committee included a vigorous anti-cycling activist, David Braunstein. Every person on every side of each issue had plenty of opportunity to have their voice heard.

Some people may complain that the plan is comprehensive and the Parks & Rec Commission had less than a week to review it before their meeting. However, the P&R Commission was integrally involved in the plan from the beginning, and when the final draft was presented to them, it was not brand new information. Rather, it was the final refinement of a living document the Commission was intimately familiar with for many months. This process was robust and comprehensive. There is no need to drag it out for further study and debate; there are just a few individuals who don't like what the plan says, and they just want more time to tilt at windmills. The City has taken ample time to let this process play out, and there is no justification to kick the can down the road. The City has a lot of work to do - such as building a new community center - and it's high time to bring this comprehensive process to an end so the City can move on to other things that need attention.

Mimi Iversen I have been following the PROS process since it began in 2020, but I didn't even realize the Open Space section was published when I heard you are ready to vote to finalize it on Tuesday. I think the public needs more time to read and discuss these very important policies that will guide the future of our treasured Open Spaces. Please delay your vote and allow more discussion. I was promised by two Council Members and Director Shearer that this Plan would address the many illegal trails as well as the speeding bikes. I notified the city 2 years ago that someone - city officials will not admit who - carved over a mile of trail through the forest behind my home for a downhill bike racecourse. This area used to be pristine and sheltered forest - exactly as John Brooks was promised when he donated this land. We used to have deer, quail and bobcat that visited my yard; now they are all gone and I blame the bike traffic for making this habitat insecure for them. They speed down hills and around curves and never yield. Many of my neighbors share similar feelings but since we don't hike there anymore our comments have been disregarded. We are still waiting for an answer from you about how you will manage this dangerous and damaging situation. Mountain biking is extremely fun, but the fragile clay soils are not ideal for the long term high volume use that we see today (especially since the advent of e-bikes which are in heavy use on the trails even today despite restrictions).

This is especially true on our wetter days (as infrequent as they are these days), where I have observed frequent new-impact from what I must presume are novice mountain bikers who may not know better.

So many embakements, corners, and trail edges have seen needless destruction from banking, carving and short-cutting to make them more exciting.

Further, many of the steeper ascents are so deeply rutted from overuse that it will take years for these trails to begin to rehabilitate.

That said, I am in favor of further recognition of many of the unofficial legacy trails to be incorporated into the official park plan for pedestrian access.

I think efforts to improve erosion control and recovery will be greatly improved if we were to do even put a temporary suspension to MTB activity for a duration (maybe 5 years?). Finding a way to quantify that effort would be paramount to reconsidering such a supension in the future.

In my mind the biggest risk to any of this mattering is a matter of enforcement, and regretfully I do not know much about how to go about that at an open space with so many points of ingress/egress.

I am a Belmont resident living in the Hallmark neighborhood. I no longer visit Waterdog trails because they are so damaged and so over-trafficked with bikes that it is not enjoyable.

I think that in order to restore our park to the pleasant setting it once was you should:

Stop the volunteers from digging up and widening the trails. I liked walking on the quiet little trails on the forest floor and enjoying the lush ferns and flowers. Volunteers hack back the plants to make it wider for their biking, and kill all the native flowers along the trail. And then they push the cuttings down the hill and they die there in piles on top of the other bushes. They dig ditches, leave useless plants, and cut back trees just so they won't bump their head. It's a depressing dead mess.

Keep bikes off all the trails in the canyons and on the slopes – Chaparral, Ohlone, Rambler, Finch, and along the hidden canyon creek where they have widened it into a freeway. There is no passing room on a 3-foot wide trail and you can't widen the trail when it's on a steep cross-slope. The plants are trampled by people getting out of the way of bikes, bikes skidding off of the tight turns, taking shortcuts on curves or switchbacks, and even on occasion sliding off of the sloped trails. The ferns and wildflowers are covered with dust from their skidding, the tree roots are exposed tripping hazards. The stairs that used to be on steep sections to make it safer to get down without sliding on your rear, have all been completely eroded away and pushed down the hills by the bikers.

Close the unmarked trails – the woods are torn up by random shortcuts, and bypasses. People make these trails for thrills so they are usually steep and straight downhill. One trail that began off of Elevator a few years ago turned into a 2-foot gully and now there is a second trail next to it, and both are so steep and graveled that they are dangerous to hike or bike. I have met hikers who are lost because they ran across some trail that is not planned and they got turned around.

Get rid of the e-bikes. I talked with a group with e-bikes and they were bragging about how many more miles they cover in a day of riding. One guy said he rode twice as far with his ebike because he doesn't get tired. Covering distance is not the point of our trails – enjoying nature is the point and they certainly aren't doing that when they are flying as fast as they possibly can. I think that if they want an aerobic workout they should use their muscles, not a motor. Or go to a gym and leave the nature trails for those who appreciate nature.

In short, someone needs to do something to manage the trails because it's a free-for-all now. When visitors see it so run down I think it sends a message that they don't have to respect nature here.

7/12/2022 To the Belmont City Council: Marisa P. Harrington Please, please stop this plan from proceeding. It does not resolve the most controversial issues that are driving hikers out of Waterdog; safety and illegal trails. Residents have not been heard. My family has lived in the neighborhood since the 80s and the open trails have become overrun with bikers, damaged from all the tracks, and are not a high risk for walkers (ESPECIALLY young children and older individuals). The plan allows biking on ALL trails regardless of safety or nature. Mountain bikers from the entire region flock to Waterdog because it is the only open space that does not regulate biking on narrow dirt trails, regardless of safety and trail damages. Bikers run timed speed competitions, build jumps and modify trails to increase speeds. Hikers on narrow and sloped trails jump out of the way into the shrubbery. Seniors, families with children, and anyone less agile are displaced by this imbalanced bike-centric climate. The plan proposes to sanction 3 miles of illegally forged, unsafe and damaging trails - none of which meet the safety or environmental standards recommended in that same document. These are steep, eroded, and dangerous for both hikers and bikers. Sanctioning this vandalism is irresponsible stewardship. The plan eliminates the ban on motorized bikes, leaving our trails wide open to all types of powerful e-bikes that are banned from dirt trails in other open spaces. For two years Belmont council members promised the Open Space Master Plan would address these dangerous and divisive issues. It doesn't. It kicks the can down the road, stating that the city should study or consider trail policies. Two wasted years does not excuse a flawed and hollow plan to guide us the next 15 years. We insist you please address these issues NOW: 1. Keep bikes off the narrow, steep and sloping dirt trails. Bikes can use 5 miles of wide trails like Lake Road. Bikers themselves are welcome on all trails, but without their machinery. This policy works in every other open space district - why not here? 2. Close ALL unsanctioned trails. These are vandalism pure and simple, and no city policy should sanction vandalism. 3. Ban e-bikes from dirt trails except Lake Road, where they serve a valid need for transit and connectivity. Visitor safety and the health of our Open Space are priorities. The sport of mountain biking should not be allowed to endanger either. Thank you, Marisa A. Passantino

- 1. They claim that banning bikes keeps them off the trails. Of course that is a lie: they can all walk on the trails. Banning bikes is not discriminatory, because the same rule applies equally to everyone.
- 2. They claim that narrow trails slow down the mountain bikers. Watch any mountain biking video! Mountain bikers see all trails as a challenge to ride as fast as possible, including over the speed limit.
- 3. They claim that hikers cause as much erosion as mountain bikers. That is a lie. All of those claims ignore speed and distance travelled. Even if they caused the same amount of erosion per mile, mountain bikers travel much farther than hikers, and therefore cause more erosion. Knobby tires are perfectly designed to tear up the soil. Shoes are not. This was elucidated in my review of the scientific literature, https://mjvande.info/scb7.htm
- 4. They claim that mountain bikers help maintain the trails. But that is simply attempting (not successfully) to fix the damage that they themselves have caused! Isn't it better not to do the damage in the first place? And there is no way to restore soil that has been eroded away.
- 5. They claim that no one can detect a difference between erosion caused by mountain biking and e-biking. But that's obviously not true: an e-bike allows one to travel much farther, thus causing that much more erosion. Their greater speed also increases the amount of erosion per mile.

We were hoping to comment via Zoom at yesterday's city council meeting on topic 9A regarding Waterdog trail access, but it got too late for us.

William, Nina, and Voneth

We just wanted to say that we support continued access to Waterdog for mountain bikers on all trails. We ride the single-track trails for exercise and recreation as a family regularly. Mountain biking is one of the few activities that we can all enjoy together. We have been (and are) Belmont residents for over 13 years now and ride to the trailhead. We have also hiked the trails, but for one of us (William) hiking is much harder on the knees and there is much less exercise involved.

As hikers and bikers, we have had a few encounters with fellow mountain bikers (and e-bikers) on some of the tighter single track trails. We worry mostly for our 12 year old son (who has been riding the trails for at least 5 years now). We have also had some interactions with hikers while we biked. We now ride with bells which has helped minimize encounters tremendously with other trail users, especially hikers (we have been thanked for having the bells by hikers on countless occasions). We try to be as courteous as possible to hikers, always stopping to let them have their right of way.

Based on our experiences as both bikers and hikers, we wouldn't be against implementing some rules for bikers AND hikers on the trails:

- 1. Bikers need to always ride with bells.
- 2. Bikers need to ride without headsets on so they can hear other trail users (bells and voices).
- 3. Hikers and Bikers should always understand the trail rules with regards to right-of-way and NOT waive their rights. (Imagine the confusion at a 4-way stop if the driver on the right insists on relinquishing their right-of-way to the driver on the left!)
- a. We often see hikers, out of courtesy, move to the side of the trail and wave oncoming bikers by. This creates confusion and an expectation on the biker's part for similar behavior by all hikers.
- b. We love the challenge of being able to climb a difficult section of trail and are often frustrated when the downhill rider refuses to relinquish the right of way and tries to squeeze by, creating a dangerous situation. Many uphill riders in similar situations will automatically pull to the side out of 'courtesy' for the downhill rider. Again, this just creates confusion and an expectation on the downhill biker's part for similar 'courtesies' from all uphill bikers.
- 4. We wouldn't be against having a small set of trails designated 'hiking only', but no more than, say, 25-30%.
- 5. We are all for a ban on e-bikers, excluding those who ride e-bikes because of disabilities.

Apologies for the long email, but we are passionate about biking and Waterdog access is one of the main reasons we chose to live in Belmont.

When I saw this article in the Daily Journal

https://www.smdailyjournal.com/news/local/belmont-to-discuss-parks-master-plan/article\_ef4a6b76-0199-11ed-b960-c338f624b0c3.html, my takeaway from it was that you're leaning towards delaying the plan to accommodate David Braunstein, Kristen Mercer, and

a handful of other people in their small circle. I understand their position, I know they want to do anything they can to enshrine restrictions to open space access in the PROS plan. I am writing to respectfully ask you to consider (1) whether this is in

the best interests of the community as a whole, and (2) whether aligning yourself with this group is a wise political move.

But first, I want to address the implication

in the article that the PROS process was somehow rushed at the end. It was not. Hundreds of pages of new documentation were not suddenly dropped on the public in the last three weeks. As Parks Director Shearer pointed out at the July 6 Parks & Recreation

Commission meeting, nearly all of the information contained in the final draft has been part of the publicly available documents for more than a month, and in some cases, several months. Also, the individuals calling for delay are almost exclusively focused

on the open space element. (Except for Mr. Braunstein, who consistently lobbies against any development of the fallow Hidden Canyon city park lot down the street from his house.) That open space element of the plan is 139 pages, and if you exclude the tables,

it's only 87 pages - and within that 87 pages there are plenty of pictures and charts.

I truly believe that adopting the PROS plan now is what's best

for the community. The City's consultant WRA concluded that existing recreational use can continue on the existing mapped and unmapped trails without causing environmental harm. (By the way, the community has been using the two unmapped trails in Waterdog

for years, and while WRA recommended improving stream crossings on one of them, it found neither trail has significant erosion, and found no justification for closing either of them.)

The plan shouldn't be delayed - and the city shouldn't spend tens of thousands more in staff and consultant time to conduct many months' worth of meetings and focus groups so a handful of dissatisfied homeowners can keep beating a dead horse. Those individuals will never be satisfied unless and until they make the open space so exclusionary and unwelcome that it keeps their streets clear of park visitors. That is just never

going to happen. And what would the ultimate result if the plan is modified for their desires? There will be a lot of Belmont voters who won't get to enjoy the open space as they have for the past 30 years, and they will be extremely unhappy about it.

In exchange, a few affluent homeowners may get the marginal benefit of a small reduction in visitors to the open space next to their houses. The needs of the many should outweigh the needs of the few- especially when the "few" voluntarily chose to purchase

homes knowing full well they were next to a popular community asset.

When I read the quotes attributed to you in the Daily Journal

that the PROS plan "needs more work," the public "(doesn't) feel the government is working for them" and we need to "clarify the policies," it sounded to me like a continuation of Mr. Braunstein and Ms. Mercer's quotes in the article, in an echo chamber completely

detached from the PROS process I participated in. I'm sure you didn't intend it that way, but it also read to me like a slap in the face to the Parks and Recreation Commission and the Parks staff. I have been following this process closely and have either

attended or watched nearly every meeting. The Commission and Department worked extremely hard, poured their hearts and souls in to the plan, and the process gave everyone more than enough opportunity to provide input. I think the plan is meticulous, amazingly

well thought out, and provides a beautiful vision for our parks and open spaces over the next 15 years. I think it would be very disdainful to the hardworking commissioners and staff if the plan is sent back for a "do-over" just because it didn't give a few

well-heeled and politically-connected constituents exactly what they wanted. I just don't understand what is vague about the plan. It's a framework, not a blueprint. The intent of the plan is not to resolve every disagreement between every member of the community about every use of every trail.

Of course, City Council is the ultimate decisionmaker on the

plan, and it has the prerogative to modify it. But allowing unelected political allies to dictate the process at the end is an affront to those of us who patiently participated in the process over the past 18 months. It feels like Lucy pulling away the football

from Charlie Brown as he's about to kick it. It also sends the message that the council doesn't have confidence in the Parks Commissioners it appointed or Parks staff it hired. It's not a good look if council is willing to just toss aside the recommendations

of the very staff and commissioners it entrusted with creating the plan if a few well-connected constituents don't like what it says. It makes Council look indecisive and ineffectual if it can't make a simple decision on a thoroughly-vetted plan that has already

gone 6 months into overtime. When I read the article, it made me wonder, who's really in charge of our city, the current council, or members of prior councils?

During this process, the commissioners and staff had to endure

what seemed to be, in my opinion, baseless accusations of misconduct, threats, abuse, and disrespect from the same crowd who are now demanding delay in adopting the plan. Don't take my world for it. Please watch the footage of P&R Commission's 7/6 meeting

and fast forward to 105:57 for an example. https://belmont-ca.granicus.com/player/clip/818?view\_id=1&redirect=true While

the opponents to this plan conducted themselves, in my opinion, in a very reprehensible way, the Commissioners and Parks staff were very professional, kept their composure and focus, didn't take it personally, and took their substantive input into consideration

As a resident of Belmont (1100 Live Oak Way) and a frequent visitor (2x to 3x per week) to the Waterdog open space, I would like to express my sincere and strong support for the Open Space Master Plan (PROS plan) that was presented by the Parks & Recreation department (and their outside consultants) to the City Council at your last meeting.

Before I begin to discuss why I support the open space plan, I'll share some of my stats. I'm a 58 year old male who has used running as a form of recreation and exercise and who has been riding mountain bikes in the Bay Area for the past 20 years. I've run the NYC marathon 5 times and the LA marathon 1 time, so I suppose it's more than just a hobby. I'm a college educated professional with a Master's degree in Curriculum & Instructions (I taught high school mathematics in Wisconsin for 10 years) and have an MBA (currently work in finance at a cyber security company based in Sunnyvale).

I've lived in Belmont for over 3 years and have been a frequent visitor to the Waterdog open space over the past 20 years. During this time, I've been a hiker, runner and mountain biker on the fire roads and single track trails. I've seen numerous junior high and high school kids riding the trails. It is great to see these kids choosing a recreational option that is something they will be able to do well into their 60s (I'm hoping even later for me:-) while also having a group experience. It's been great to see. I've also had the opportunity to ride with a group of guys all in the 70s.

I'd like to address some of the concerns that others have expressed in opposition to the Open Space Master Plan as it relates to the riding of mountain bikes in Waterdog. The bikes are scaring away the wildlife: In the past month, I've seen multiple deer grazing on the side of the trails, had a fawn run up a fireroad some 20 feet in front of me (we were both very surprised to see each other), had a baby quail literally run between the two wheels on my bike (again, we were both very surprised by this) and have seen numerous cottontail rabbits, quail and lizards (if that is what they are) dart across the trail. Earlier in the year, my friends and I came across a rattlesnake in the sun at the top of the 18 switchbacks, fortunately the snake moved on without any issues.

Speed. Technology these days can tell us a lot of things. My normal ride is 8 miles. Over the course of these miles I climb 1,300 feet. I find the challenge to be a great workout. One of the concerns being expressed is excessive speed by mountain bikers. I'd like to point out a couple of things. First, according to my garmin watch, my average moving speed during my 8 mile ride is 6 mph. The single track trials are very windy, which reduces speed and the hills...well, they are steep in several places, again reducing speed. Second, I am able to ride faster on the fire roads, taking into account other traffic (hikers, bikers and other mountain bikers). The opposition is asking that the mountain bikes be only allowed to ride the fire roads, but that is where bikes would be going the fastest...not to mention, the variety is in the single tracks.

Other users. I encounter other users of the park every time I'm in the park on my mountain bike. All users have been very courteous and careful to respect each other. I follow the rules of engagement, which is that bikers yield to hikers and runners and downhill riders yield to uphill riders. I've never had an incident or even a complaint leveled at me. The only issue I've ever had has been a hiker with a german sheppard. This dog is terrified of bikes and has tried to attack me a few times. I don't see this as the dog's fault, but the fault of the dog's owner who knows of their dog's fear of bikes. Fortunately, I was never injured and it's been a while since I've seen the woman and her dog on the trails. All bikes should be banned because I had an incident. Although the inconsiderate ones are very few, I'm sure something has happened along the way. That said, there are also very bad drivers on the freeways and streets of Belmont, and yet we do not ban all cars. I see no difference here. All parties can co-exist on the Waterdog trails if proper etiquette is followed, don't blame everyone for the bad behavior of a very small minority. Given the years and years of riding that has been happening on Waterdog's trails, I would like to see a police (or maybe it's fire) department report of the number of reported injuries/collisions within the park that has occurred due to an encounter with a mountain bike. I've not heard of any, but if the data exists, it would be good to know

I attended several of the virtual meetings that were held by the Parks & Recreation department over the past 18 months. I believe the work that was done by P&R and their outside consultants was very complete and they heard from the public (including the opposition) several times during the process. The same people who have stated that they only just learned about the plans or haven't been able to express their concerns have been speaking at these public meetings.

I've enjoyed the trail variety, the vertical nature of the park, and the uniqueness of this great recreational areas surrounded by the Belmont community. Waterdog has been successfully managed as a mutli-use trail system for decades. This special park should continue to be available for all users who have been able to co-exist within the ecosystem of the park.

I have attended every P&R and PROS meeting regarding the OSMP for the past 2 years and my observations should be of interest to all of you elected officials that represent us.

The Developed Park Specific plans were discussed thoroughly and in depth with focus groups that involved each community for the past 18 months (kudos where kudos are due). For the past 18 months, I have participated in some of the Park Specific plans including my own Hallmark Park where the major resident theme was clearly: Let the NATURAL beauty flourish with the least amount of development and man-made amenities added to our local parks.

However, the Open Space portion of the OSMP was crammed into a very short process (3 months) with an appearance of attempting to sweep the illegal issues that have dominated our Open Space for the past 30+ years under the rug yet again. I patiently waited 15 months for the outsourced OSMP consultants' reports that were finally hurriedly presented in March, 2022 with no specifics. At that time the WRA assessment was not even available, and the PROS advisory meeting had nothing to review. I subsequently sent several emails to all the P&R entities contradicting their vague and incomplete assessments. I commented on them at every public comment meeting after the March 5 initial assessment, obviously to no avail, because when the 136 page Final draft was released on July 6, I realized that no comments were incorporated – the draft was exactly as the original. I could see that P&R commissioners struggled at the July 6 meeting to approve this plan, most of them not having read it entirely. They finally approved sending this incomplete and inaccurate outsourced plan with vague "amendment recommendations" to CC on July 12.

I am coming to you, City Council with the same issues I diligently presented to the entire PR team. You are the ultimate authority for the City of Belmont to argue against the powerful biker lobby (mostly non residents) that have illegally taken over Waterdog for the past 20+ years by their own admission; bikers being allowed on ALL trails instead of the multi-use designated trails as designated in the 1992 plan (https://www.waterdogpreserve.org/city-policies-ignored-1), bikers being allowed to build illegal trails anywhere in the Open Space with no City authorization or geological safety trail assessments (https://www.waterdogpreserve.org/brooks-contract-violated) and bikers illegally using E-bikes already on Waterdog trails for many years (https://www.waterdogpreserve.org/ebike-speeding).

Nearly 2 years ago, I personally presented my carefully researched John Brooks Preserve PP to Brigitte to highlight the illegal Soho trail violations including violations of the 1977 donation contract to the City. At that time, Brigitte told me, she was the "new sheriff in town" which gave me hope because all this illegal activity was done before her watch. But to date, none of the three issues I mentioned above have been properly addressed and in particular, this illegal trail in the JB Preserve is audaciously being considered as a one way downhill slalom bike trail.

I always use my precious 2-3 minute public comment time to address the relevant concerns and issues while bikers use their time to continually reiterate the same obsequious comments arguing that ALL trails should be multi-use; never even considering the safety, habitat and environmental damages that have occurred from their constant use. Two of the leading local biker advocates (Thaddeus Block & Kevin Sullivan) were actually Belmont Park and Rec commissioners during the time when all this illegal activity occurred. Ad nauseam, they repeat that because they help maintain the trails, they should have access to ALL trails. They fail to mention that they have been the ones building all the illegal trails for their own enjoyment and entertainment because no other local parks allow it. (This begs another question; why is Belmont one of only 2 Open Spaces in the entire Peninsula allowing it?) How is volunteering to clean up the trails they damaged and building illegal trails without authorization justify their reasoning? One of my neighbors even asked if "Belmont gets kickbacks from outsiders"!

As elected representatives to our City of Belmont, we residents expect you to address taxpayers' concerns and issues before catering to the powerful non-resident biking lobby. Contrary to biker "fake news", residents do not want to ban bikes from Waterdog and residents do agree with equitable use for all and inclusiveness from all over the Bay Area. But the pendulum has swung too far in the wrong direction and now residents need safety on narrow trails for hikers only, residents need illegal trails such as Soho trail (Labor of Love) closed and E-bikes banned except on Lake road for transit connectivity.

In a time where citizens have the lowest confidence in our government, now is the time for you as elected officials of Belmont to step up, spend the time on the proper process and address these important issues to regain credibility and transparency among your constituents. I trust you will.

Waterdog Open Space Plan (OSMP) (These remarks pertain to to the John Brooks Trail and not necessarily to the Waterdog Lake Road Trail. However, it is evident that any plans that include all trails must be complex and not rushed.) Having lived for 44 years in my house on Wakefield Drive bordered by the upper John Brooks Trail, I have observed our serene source of direct communication with the wonders of Nature devolve into a sometimes disturbing conflict between strollers or joggers with one or more bicyclists vying for a position on the trail, especially on narrow or 'blind' portions of the path. I have fond memories of strolling walkers, some with young children or animals in tow, without the interruption of competing bicyclists or occasional powered bicycles. Lately, I see or hear conflicts between hikers and bicyclists because two objects cannot occupy the same space at the same time. Currently, the strollers, children and animals (sometimes perilously) are required to step off the trail to allow the bicyclists to pass. Having trained locally for 6 months to walk in the Anchorage Midnight Sun 26.2-mile marathon in the past, I am familiar with most local trails-some can easily and safely accommodate hikers, joggers and bicyclists, some cannot safely. For example, the nearby six-mile paved Sawyer Camp Trail was designed and built to safely allow foot and bike traffic, the John Brooks Trail, mostly dirt along perilous precipices, was designed for walking or jogging, not to commingle both foot and bicycle traffic. I urge you not to despoil our precious Water Dog John Brooks Trail and nature preserve (designed for us as our access to immerse ourselves in the wonders of Mother Nature) by designing it to also become a bicycle path in opposition to its original intention by our wise City officials 50 years ago. Perhaps the bicyclists can use the Waterdog Lake Road Trail or the Sawyer Camp Trail, nearby and designed for multi-use. Both of these alternatives are safer for our citizens and minimize costly civil damage claims. Thank you,
